## SPECIAL RESOLUTIONS FOR THE 2013 ANNUAL GENERAL MEETING

The following Special Resolutions to alter the By-Laws of the Federation of Post-Secondary Educators of BC will be presented for debate and vote at the 2013 Annual General Meeting, being held May 15-17 at Nanaimo, BC.

**Note to delegates:** Special resolutions require a 3/4 majority to pass.

### 1. MEMBERSHIP

#### (1) 1.2 Individual Membership

**1.2.2 Where no local association exists at a college or institute an institution, or where a local association is not a regular or associate member, individual faculty members may elect to become provincial members of this Federation. ...**

### 9. REVENUE

**(2) 9.4 ... Regular members and associate members that become regular members or that opt into the Defence Fund and regular members that join after the charter period (May 31, 1986 to June 30, 1986) shall not be eligible to receive financial payments from the Fund until at least six (6) months after joining the Fund. ...**

### 10. AMENDMENTS

**(3) 10.1 ... An amendment shall take effect on the date passed of its acceptance by the registrar as being in compliance with the Society Act, or, when the amendment is accepted by the registrar and a later date is or as specified in the amendment, on that later date.**
