

HRISC **[137]** Ensure that materials designed by FPSE for the public represents community diversity.

EPC **[085]** That Presidents' Council establish policies, procedures, supports, and infrastructure to facilitate the orderly collection, storage, and analysis of data from local members and other sources in order to facilitate the Federation's policy development and coordination and collaboration of its members policy development. Be it further resolved that member local will have access to such data, Be it finally resolved that PC reports on the progress of this initiative at the next AGM.

DRISC **[075]** That FPSE explore and commit to a shared governance model that includes DRISC.

BCC **[095]** That PC will seek recommendations from BCC on appointees for Faculty Bargaining Coordinator positions.

BCC **[096]** That PC ensure FPSE has a dedicated role to support bargaining co-ordination in a timely manner. This includes the capacity to perform research, to analyze, compare and communicate data, and to inform locals about what is occurring across FPSE and the province during bargaining.

Presidents' Council **[121]** That FPSE adopt and operationalize the recommendations of the "Prioritizing Equity" initiative to advance the equity work of the Federation, with recognition of the current and ongoing work taking place at FPSE locals and within FPSE committees.

02 TRUFA **[092]** The Federation will change the name of the Status of Women Committee to Gender Equity Committee, to recognize gender as inclusive of non-binary and trans peoples.

15 VCCFA **[098]** That FPSE Policies 8.11.1.7 and 8.11.4 be merged, renumbered and amended to read: 8.11.1. Free Tuition 8.11.1.1 FPSE calls for and advocates that by September 2025, the BC government will have removed all tuition for Canadian citizens and permanent residents for all programs of two years or less duration and removed all tuition for the first two years within all programs of more than two year's duration. 8.11.1.2 As part of its advocacy FPSE calls for programming to be fully-funded at levels commensurate with student demand and without reliance on increasing any remaining student fees.
